SALE AGREEMENT for December-January 2021/22 delivery of Chance-mated 2020/2021 Spring/Autumn born Friesian Beef X Heifers (**Hereford Friesian**) (**Friesian Murray Grey**) (**Charolais or Simmental x Friesian**) (**Angus Friesian**) heifers, between Genetic Development (NZ) Exports Limited Partnership, and:

The Vendor agrees to offer the specified number of Friesian X heifers for purchase as listed, according to the conditions listed below:

All Heifers must be Dehorned and healed prior to Delivery to comply with MPI regulations All Heifers will be purchased at per kg rate of \$3.50kg for heifers between 260-350kg for North Island and \$3.30kg for South Island for heifers between 260-350kg. The price is capped at \$1100 for heifers from North Island and at \$1050 for heifers from South Island. The maximum weight we can accept up to is 370Kgs.

All vendors must agree to running a bull with the heifers as soon as possible after tagging. Angus or Hereford bulls can be provided, or the farmer can use a suitable bull already on farm but only after the bull/s have been tested negative for IBR and then vaccinated.

1. The heifers to be purchased are tagged with export ear tags. The heifers must not be vaccinated for IBR (Infectious Bovine Rhinotracheitis).

On Farm 6 months i.e., NAIT transferred to grazing location.

2. Only heifers that pass Farm of Origin testing required to enter Pre-Export Isolation for shipment to China will be purchased. (Tests include a TB test, plus blood tests for Johnes Disease, BVD Antigen and IBR antibody). The testing will occur in timely manner. To be eligible for testing the heifers must have resided on that NAIT location for at least 6 months and a declaration to confirm this will be completed by the vendor.

Blood Testing

3. If more than 50% of the mob of cattle fail the IBR blood tests, then this contract becomes void at the discretion of the purchaser. In this event the deposit will be refunded in full within 14 days of written confirmation of this decision.

Delivery

4. Delivery will occur within 3 weeks of testing.

Minimum weight of the Beef heifers will be at least 260 kg live weight at the time of delivery December-January. Any heifers that are rejected at the PEI for not meeting the criteria, will be sold on behalf of the vendor at the closest suitable sale. If possible, please weigh heifers before collection of animals."

4A. Heifers weighing down to 240kg off truck to PEI will be accepted. Paid weight is then calculated after the regional travel adjustment.

Payment

5. Terms of payment are within 14 days of delivery or upon the purchaser receiving all relevant NAIT records on NAIT No. provided. Full title to the property of the livestock shall not pass to the Purchaser until payment is paid in full.

Vendor Warranties

Vendor will complete an Asure Quality Owner Declaration for export to China and will provide veterinarian certification that the cattle location meets the required Farm health status.

All cattle must be in good health with AHB & NAIT approved identification. All cattle must be dehorned All cattle must be free from IBR and BVD.

All cattle should be Eczema free – no obvious skin lesions.

If scours develop post inspection, consult your veterinarian. (Use Baycox C treatment if Coccidia)

The cattle shall be free from deformity or defects including lameness, blindness, eye infections, pink eye, supernumerary teats, or hernia, open wounds, sore or swollen legs or joints, and freemartins are excluded. If any animal is found of these when they arrive at our PEI, they will be paid local market price.

The heifers will be free from warts, ringworm and all clinical signs of external parasites or disease.
